

#### Saturday, June 18<sup>th</sup>, 2016 Auditorium at Mission Bay High School

The Miss Mission Beach Pageant is a fundraising event that donates proceeds to various Adaptive Sports events within San Diego County. The Miss Mission Beach San Diego organization is a 501c3 all volunteer non-profit organization.

We provide the opportunity for women over 18 years old to compete for the Miss Mission Beach (MMB) title. MMB is required to make numerous appearances during the year on behalf of the Miss Mission Beach Organization at various Adaptive Sports Events, Wheelchair Events, parades and other events. These events will be scheduled to help promote the Miss Mission Beach Title and support Adaptive Sports Events. It will also give those women who seek a "Miss Title" an opportunity to go on to other pageants.

Entry packages are due by May 10<sup>th</sup>, including the \$150 entry fee. If the entry package is received after May 10<sup>th</sup>, the entry fee will go up to \$175. All checks are to be made out to "Miss Mission Beach San Diego". There is a \$25 referral discount available towards your entry fee for each contestant you refer (up to a maximum of 2 referrals). In addition, contestants are encouraged to secure a \$250 sponsor, which can offset their entry fee. All contributions raised need to be provided to the Miss Mission Beach Organization no later than one month prior to the pageant. Keep in mind this is a 501c3 non-profit that benefits Adaptive Sports Events in San Diego County and could be a tax deduction.

Pageant Categories include: Miss Mission Beach 2016, 1<sup>st</sup> Princess, 2<sup>nd</sup> Princess and People's Choice. People's Choice will be determined by crowd donations during the pageant.

We are limited to the number of contestant openings, so please send in your entry form to reserve a contestant space as soon as possible. There will be a <u>mandatory</u> contestant meeting one evening during the first week of June 2016 (date to be determined). At this meeting, we will answer any last minute questions and give more details on the Pageant. Contestants are required to attend. The date, time and location will be provided in your confirmation email.

This year's pageant will be held in the Auditorium of the Mission Bay High School on **Saturday**, **June 18**, **2016 at 6:00 pm**. Mission Bay High School is located at **2475 Grand Avenue**, **San Diego**, **CA 92109**.

Contestants will be provided storage and a changing area during the pageant. The contestants will not be able to have contact with visitors or guests before or during the pageant. You will be able to visit with your family & friends once the MMB Pageant has concluded.

#### **RULES, REGULATIONS & AGREEMENT**

I,	born on
hereby apply for eligibility to p	participate in the Miss Mission Beach Pageant.

- 1. I am at least 18 years old. I was born a female and I am not married.
- 2. I will appear at the appointed time and place for all stage appearances, photos sessions and interviews unless prevented from doing so for reasons beyond my control or unless I have permission by the pageant director to do otherwise. This also includes reporting to the dressing rooms at the required times during the pageant.
- 3. I have truthfully disclosed my age, address, place of birth and have willingly disclosed all reasonable, necessary personal data as requested by the Miss Mission Beach Pageant.
- 4. I understand that if I should obtain any knowledge of the identity of the pageant judges, I, my parents, friends, relatives, etc. will not engage any of them in conversation at any time prior to the conclusion of the pageant.
- 5. I understand that I am accepting the responsibility for representing the Mission Beach area and that my public and personal conduct will be of the utmost concern during my reign. If my moral or personal conduct should for any reason become embarrassing to the Miss Mission Beach organization or the Miss Mission Beach Pageant, I will willingly give up my title and prizes. If I fail to attend the required events, all prizes shall be returned to the pageant committee who will transfer the title to the next available court member.
- 6. I understand that one of the areas of judging will be based on my personal appearance. <u>I agree not to extremely alter my personal appearance</u> should I become Miss Mission Beach, with offensive tattoos or piercings that were NOT present when I won the title and keep this appearance during my rein as Miss Mission Beach.
- 7. I agree to provide my own transportation to and from all appearances. I live within San Diego County.
- 8. I understand that I must never have posed naked, worked as a topless model or dancer, or have been, or be currently involved in pornography.
- 9. I understand that I must use courtesy and proper language at all MMB events, as well as when dealing with other contestants and pageant staff.
- 10. I understand that if selected as Miss Mission Beach, I cannot use the title to endorse any products or businesses for advertising purposes or make appearances as MMB without authorization of the Miss Mission Beach Pageant Organization.



11. I agree that if I am successful in being crowned Miss Mission Beach (MMB), or Miss Mission Beach 1<sup>st</sup> Princess, I am required to attend 8 to 10 events annually in order to qualify for the 2<sup>nd</sup> half of my prize money (to be paid in March). These events will include adaptive sporting events where I may be required to function as a volunteer in my official capacity as Miss Mission Beach or Miss Mission Beach 1<sup>st</sup> Princess. Additionally, there will be other public functions (i.e. parades, fundraisers) where I may also be called upon to represent the Miss Mission Beach Pageant. These events vary year to year, therefore dates will be provided to me in a timely manner. I may also submit a request for permission to attend any new event to the MMB Board at any time during my reign, with reasonable advance notice (preferably two weeks), attendance of which may count as one of my required appearances.

#### WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO INDEMNIFY AND HOLD HARMLESS

In consideration of entry into and participation in the activities associated with MISS MISSION BEACH SAN DIEGO (herein after "MMBSD") and in recognition of the risk of injury while participating in MMBSD activities and as consideration for the right to participate in the activities, I hereby for myself, my heirs, executors, administrators, assigns, or personal representatives knowingly and voluntarily enter into this WAIVER and RELEASE OF LIABILITY and hereby WAIVE any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation and do hereby RELEASE and forever discharge MMBSD and their affiliates, managers, members, agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, the event site and its agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns and all sponsors and/or beneficiaries of MMBSD from any and all liability, claims, demands, damages, actions or causes of action of every kind and character now existing or which hereinafter may arise as a result of my participation regardless of cause or whether any injury is caused by the sole, joint, comparative, or concurrent negligence or gross negligence or fault of MMBSD, the negligence or fault of myself or third parties, the conditions of the event site or any other cause.

Further and for the consideration herein described, I agree to INDEMNIFY and HOLD HARMLESS **MMBSD** against any and all claims, demands, damages, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees, if litigation arises on account of claims made by me or anyone on my behalf caused by negligence, gross negligence, negligence per se, strict liability arising out of or related to **MMBSD** and/or my participation in **MMBSD** to the extent permitted by law.

I recognize that various photographs, video recordings and/or other media will be taken during MMBSD's activities. I agree to grant MMBSD full permission to use any and all photographs, video recordings, or other media of MMBSD activities that contain my likeness, including photographs I have provided with my entry packet, for the purpose of promoting MMBSD or its SPONSORS in any manner deemed appropriate by MMBSD. I understand I have no right to and shall not receive any monetary payment for any photograph or recording (audio or video) in which I may appear in connection with or relating to MMBSD. I further agree to RELEASE and INDEMNIFY MMBSD for any claims of NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, STRICT LIABILITY or LIABILITY or other fault for claims made that relate to any usage of photographs and/or interviews, including but not limited to damages, losses, costs of defense, attorney's fees and whether caused by the sole, joint, comparative or concurrent negligence, gross negligence or fault of MMBSD or myself or third parties, the conditions of the event site or any other cause.

#### PAGEANT CHECKLIST

Below is a list of items you MUST have on the day of the pageant. Use this list as a guide and checklist as you prepare for the pageant. It is always a good idea to use it again as a checklist the night before and/or the morning of the pageant, before you leave your house, double check that you have EVERYTHING that you will need for the day. If you have any questions, please feel free to call any member of the Pageant Staff.

- 1) Opening on stage appearance Casual Beach Attire.
- 2) Casual Beach Attire will be worn for your interview.
- 3) Swimwear Swimsuit / Bikini
- 4) Evening Gown Final change (crowned in).
- 5) A cover-up Lightweight cover up.
- 6) Snacks/Lunch/Water Provided (you will not be allowed to leave the contestant area). It is a good idea to bring your own snacks if you have any special dietary needs.
- 7) Small make-up bag and mirror to touch up your make-up. You will be having pictures taken prior to and during the pageant. **Be considerate to your fellow contestants.**
- 8) One bag all of your belongings should be packed into one bag. There will not be enough room in the dressing area for each contestant to have several bags or suitcases.
- 9) Contestants should arrive with hair and makeup completed.
- 10) The Dressing Room is an area that will be shared by all contestants. Please limit your need for running water / sink due to the number of contestants. Be courteous of your fellow contestants. There will be tables and chairs provided in the changing area, they may be used for make up, mirrors, etc.
- 11) EVERYONE is responsible for cleaning up the changing area. The staff is there to help you, NOT CLEAN UP AFTER YOU. Once you are in your Evening Gown, everyone needs to get packed up and everything cleaned up.
